REPORTING INSTRUCTIONS:

SURVEY ON SHIPMANAGEMENT COMPANIES

What forms are included in the Survey and when should they be completed?

Survey "SM" consists of two forms as follows:

Form 1

- 1.1 Details of current reporting
- 1.2 Details of the person responsible for filling in Survey "SM" / representative
- 1.3 Identification of the resident reporting entity

Completion of this form is compulsory.

Form 2

- 2.1 Income from services rendered by the resident reporting entity to ships owned by non residents of Cyprus¹

 This form should be completed if the resident shipmanagement company offers management services to both cyprus flag and foreign flag ships owned by non residents of Cyprus.
- 2.2 Gross revenue with information on type of: ship, service, contract and duration of contract.

This form should be completed if the resident shipmanagement company offers management services to ships owned by both residents and non residents .

2.3 – Analysis of management fees received from shipowning companies whose ships are managed by the reporting entity and whose owner is a non-resident entity.

This form should be completed only if the criterion for the completion of form 2.1 above applies.

3 – Expenses incurred by the resident reporting entity

Completion of this form is compulsory.

¹ "Non resident of Cyprus" means any natural or legal person which does not fall under the term "resident of Cyprus" as assigned to it in the Directive on the definition of the term "resident of Cyprus" for statistical purposes of 2008, which can be found in the Central Bank of Cyprus' website http://www.centralbank.cy.

Reporting currency

Reporting entities are required to report data in euro (rounded to the nearest unit).

Transactions denominated in foreign currencies are to be converted at actual rates on the date of transaction, or otherwise, at the middle rate of the euro foreign exchange reference rate in the appropriate reporting period.

Sign convention

Data should be reported without a sign since the forms differentiate between income and expenditure.

Valuation of data

Market value should be used to report all holdings of securities.

Assets and liabilities should be recorded at current, rather than historical value.

The balances to be reported (for opening and closing periods) are in principle to be valued at current market prices. If however, the market value is not available, then a recent assessment of the value by the directors or otherwise the historical cost may be used instead.

Transactions/flows are to be valued at the price at which they are entered in the reporting entity's or the non resident entity's books, i.e. at the agreed transaction price, which in most cases corresponds with the market price.

Dividends, interest and rents are to be valued at the price at which they are entered in the reporting entity's or the non resident entity's books.

Estimates

If actual figures are not available for any item, provisional figures must be submitted on the basis of prudent estimates in order to ensure that submission takes place within the time limit.
