The European Banking Authority's Database identifies the Cypriot Credit Institutions with the Company Registration Number (provided by the Department of the Registrar of Companies and Official Receiver) according to released information on the type of identification number used in the registers. The reason such a Unique Identifier is required, pursuant to Article 34 of Commission Delegated Regulation (EU) 2018/389 of 27 November 2017, is for the issue of a Qualified Website Authentication Certificate (QWAC); hence, the company registration number shall be used on eIDAS certificates and to allow the crosschecking of information in multiple platforms.
